# TERMS AND CONDITIONS OF ISSUE OF COURTCARD

---

*It is acknowledged that the Courtcard to which this application relates is issued upon the following terms and conditions.*

1. The cardholder is solely responsible for the Courtcard and all courts booked on that card in all respects. A card should not be used by any other person other than the owner.
2. Notwithstanding the provisions of Clause 1 above, the Courtcard at all times remains the property of Badminton North Harbour. The Applicant shall at no time gain or retain any right of ownership in respect of the Courtcard.
3. **Card Deposits**  
To book a court you require sufficient funds on the card to cover the court cost.  
Top up your card by either;
  - a. Coming in to the Badminton North Harbour Office or Pro Shop
  - b. Over the phone with a credit card
4. **Fees**  
Badminton North Harbour reserves the right to charge such fees as it considers (at its sole discretion) to be fair and reasonable, including (but not limited) to:
  - a) An annual Courtcard service fee, such fee to be deducted from the card on or about 30 June each year. In the event that there are insufficient funds on the card by 30 June, then Badminton North Harbour shall have the right to make the card invalid until such time that the fee is paid.
  - b) A court card fee is charged at time of the application. This is a one off fee for the court card. This fee also applies to any replacement card. It is the responsibility of the cardholder to replace cards which are lost or damaged.
  - c) A Court hire fee as Badminton North Harbour may from time to time consider appropriate.
5. **Card Cancellation**  
Badminton North Harbour reserves the right to cancel a Courtcard and/or its validity for such reasons as it (at its sole discretion) may consider appropriate, including (but not limited) to:
  - a) If the Court card remains unused for such period as Badminton North Harbour considers indicates that the cardholder no longer wishes to utilise the Courtcard. In such case, Badminton North Harbour may, at its sole discretion, request the recall of the Courtcard to permit the Courtcard to be reissued. (In the case of such recall, payment of any credit balance held to the account of the Courtcard shall be made to the cardholder upon receipt by Badminton North Harbour of the Courtcard.)
  - b) In the event of any conduct on the part of the cardholder which Badminton North Harbour considers (at its sole discretion) to be a misuse of its facilities, or misconduct by the cardholder.
6. Badminton North Harbour reserves the right to:
  - a) Amend or change the Courtcard system
  - b) Amend or change the Courtcard itself (in which case Badminton North Harbour shall be entitled to require that the Courtcard be returned, and a new Courtcard issued in its place, upon such terms and conditions as Badminton North Harbour, at its sole discretion, shall consider appropriate).
  - c) Institute such new fees and charges in respect of the Courtcard as Badminton North Harbour requires.
  - d) Alter fees and/or charges payable in respect of the Courtcard and/or the basis for charging of such fees or charges.
7. Notices of any sort shall be deemed to be properly communicated if posted, emailed or Txt by Badminton North Harbour to the last known information of the cardholder. It shall be deemed that the said notice is considered to have been received by the cardholder on the second working day after the posting of such notice.
8. If a card over three years old ceases to function correctly, it will be the responsibility of the cardholder to replace it.
9. **Court Booking**
  - a) Card-holders may only book courts up to 22 days in advance.
  - b) Each card may only book one court per hour.
  - c) If a court is cancelled within 24 hours of playing the court charge will remain unless that court is booked by another user. When the court is booked by another user you receive a refund direct on to your card less a \$1.50 administration fee. Cancellations made outside the 24hr period will receive a full refund.
