PRESIDENT'S REPORT

The Board has had another impressive year in terms of what it has managed to achieve for Badminton North Harbour.

One of the strengths of a governing body is to always be looking to improve the fortunes of the organisation it serves. No matter how good an organisation is performing there is always room for improvement and the need to prepare for future eventualities (whether planned, or otherwise).

What most of our members will not see is the time and effort which your Board members put into working on these issues. One of the obvious issues which we have been working on, for some considerable period, is the need for more court space. We have had many false starts and, to be honest, do not have a solution to this problem at this point in time. This is a matter which is foremost in our minds. It is discussed at every Board meeting (and, often, in between meetings). We have a Board subcommittee which focusses on this issue and our CEO Glenn Cox is in constant contact with all of the important parties, potential partners etc. Sourcing further court availability which is in the appropriate localities, and is cost effective, is not an easy task (as you can imagine). In addition, there are certain frameworks which are imposed upon us (by funders, Council etc.) and we need to find ways of making ourselves fit into the necessary criteria to make ourselves eligible, to the greatest degree possible, for whatever possibilities might arise.

In addition, the Board has to be "across" all of the other aspects of the operation of the association. While Glenn and his team do an amazing job of the day to day management of these issues, the Board has to ensure that we have the appropriate resourcing (which is not

only financial) for everything from management of the Association's facilities, to organisation of our competitions, ensuring that we have the best available players available to form the best teams to take part in provincial and national competitions, ensuring that we have pathways in place for our elite players to reach the highest possible level, ensuring that our non-elite players also have the ability and opportunity to play at their best possible level, administration and officiating of the sport, etc. Of course, a primary driver for all of those issues is our ability to finance these activities on an ongoing basis (both short-term and long-term).

Your Board is made up of people with a variety of skills and experience. It is the combined efforts of those people who maintain Badminton North Harbour as the preeminent Badminton Association in New Zealand, continuing the good work which has been carried out by Boards in the past.

This year's Board is no exception to the above comments. They worked incredibly hard and well together to continue the good fortunes of Badminton North Harbour. Particular credit and thanks must go to Karen Blank who has taken on the position as Chair of the Board with enthusiasm, great dedication and leadership.

I am looking forward to an exciting and successful year to come for our great organisation.

2018 has seen a continuation of successes, both on and off the court. Strong club membership alongside card holders and the community's casual players have seen record numbers through these facilities, participating in tournaments, representative teams and domestic competitions.

Abhinav Manota, Oscar Guo, Edward Lau, Dylan Soedjasa and Maika Phillips represented New Zealand in the Victor Oceania Men's Team Championships, while Anona Pak, Gaea Galvez and Justine Villegas represented New Zealand in the Victor Oceania Women's Team Championships. Abhinav also represented New Zealand at the World Championships held in China in August and Oscar represented New Zealand at the Youth Olympic Games held in Argentina in October. Oscar Guo, Shaunna Li and Edward Lau have also travelled to Canada as part of the New Zealand junior team to compete at the World Junior Championships.

Our players once again achieved great success at National Championships with Harbour winning the singles, men's doubles, women's doubles and mixed doubles titles. Oscar Guo achieved a triple crown at the Yonex New Zealand u19 Championships while Shaunna Li won the girls singles at 15 years of age. Our representative teams once again had an enjoyable season. Our Division 1 team featured on Sky TV and finished second at the Yonex Division 1 & 2 Championships. Our Division 3 team won their national competition and Division 4 won their North Island competition. Our Masters 1 and 5 teams won their North Island competitions and the North Harbour u19 team took out first place at the Yonex Team Championships.

We are extremely fortunate to have such a great team at Badminton North Harbour and I would like to take this opportunity to thank them all. Fanny Megahwati, our Coaching Manager and her team of coaches, keep our players developing across all age groups. Abhinav Manota's knowledge and enthusiasm amongst our development programs keeps opening pathways for many aspiring players. Lisa Schmidt's ongoing

passion to our association and sport keeps delivering domestic, national and international competitions to a high level of excellence. Annabelle Galvez, our Secretary, tirelessly commits to ensuring our office and its administration runs smoothly. Karen Willins, our Accounts Manager and longest serving Harbour staff member with over 25 years with the association, keeps all the books balanced and in order, enabling us to be most efficient and on track. COACHING MANAGER'S REPORT

It has been another good year for North Harbour's badminton players and teams. During the 2019 season, representatives have been busy with inter-association events in seniors, masters, veterans and super-veterans. Junior and senior representatives have also been involved in a number of national and international tournaments. A number of our players achievements in 2019 deserve recognition.

Abhinav Manota, New Zealand representative and North Harbour Development Officer, qualified for the TOTAL BWF World Championships 2018 in Nanjing, China. The experience gained from an event such as this is second to none and will be very helpful in future tournaments. Abhinav also won the New Zealand National men's singles title and Oceania men's single title.

North Harbour junior, Oscar Guo has recently finished his campaign at the Youth Olympic Games in Buenos Aires, Argentina. Oscar finished

his men's singles campaign with a one win, one loss result which didn't allow him to progress. There was however the exciting prospect of being in an international eight-person team with an event called Team Relay. Oscar's team, Omega had a fantastic campaign and finished the event in second place, earning the team silver Youth Olympic medals. Other achievements for 2018 have been at the New Zealand u19 Championships, winning the men's singles, doubles and

mixed doubles titles. Traveling as a member of the New Zealand Junior Team, Oscar also won the 2018 Australian Junior International men's singles.

We have three players representing New Zealand travelling to the World Junior Championships in Canada. Oscar Guo, Edward Lau and Shaunna Li will play a team event followed by the individual championships.

Anona Pak, winner of the Massey University Academy of Sport Sportswoman of the Year Award, paired up with North Harbour's Fransisca Rahardja in the Crown Group Australian Open 2018 and reached the quarter finals which is a great achievement. Anona also won the women's doubles title at the Yonex New Zealand National Championships with partner Christine Zhang.

Wisden Cup this year followed a new format of 5 matches per tie. Our division 1 team finished second behind a strong Waikato team. Division 3 and 4 won their divisions as did the Masters 1 team, for a third consecutive year. Masters 5 who played in division 5 will be promoted to division 4 in 2019 after winning their division.

Each year we have a training camp at the end and beginning of the season. This camp is open for players from other associations should they wish to participate. This is a five-day camp, training three times each day, emphasising on fitness, technique and improving skills. This will run from 10-14 December 2018 and 21-25 January 2019.

Our major junior event for the year is the New Zealand Junior Team Championships in Palmerston North. This year we sent seven teams including two teams of u13 age players which is positive for our development. North Harbour won the u19 team event and came runner up in the u17, u15 and u13 age groups, while the u13 II team won the second division event.

North Harbour junior players have achieved well in tournaments during 2018. Jaden Mingoa won the boys doubles and was runner up in the boys' singles and mixed doubles at the Yonex New Zealand u13 Championships. Shaunna Li showed that she is a rising player by winning the u17 and u19 girls singles and runner up in the u17 and u19 mixed doubles at this year's age group championships. Ricky Cheng has improved significantly, winning the New Zealand u17 boys singles title and was runner up in the boys' doubles. Equally making good gains is Nelson Zhang who came runner up at the Yonex New Zealand u17 Championships in the boys' doubles and mixed doubles.

I would like to introduce our new coach, Hanna Yun from Korea. She will assist in the coaching of our squads to help with technical aspects of the training ready for 2019.

I would like to thank all parents, staff, coaches, players and stakeholders who have helped during 2018. Without them we would not be achieving the results we have and creating an Association that is moving forward with our successes. The North Harbour badminton community is very strong and supportive, for which I thank you.

DEVELOPMENT OFFICER'S REPORT

BWF Shuttle Time Coach Course:

Badminton North Harbour is going to run it's first BWF Shuttle Time coach course. So far, we have received more than 10 teachers from different schools wishing to participate in this course. The Shuttle Time coach course is where the attendee becomes trained to deliver Shuttle Time to children in a school or club setting. This is a practical coaching course, helping new and experienced coaches to plan and deliver fun badminton lessons to pupils aged 5-15 years old. Shuttle Time also offers free teaching resources, which include: teachers manual, 22 lesson plans and 92 supporting video clips.

BWF Shuttle Time lessons are designed to provide children with a positive image of badminton through many opportunities to have fun, engage with others and experience success.

Benefits of Shuttle Time Lessons:

- Boys and Girls can play together
- Accessible indoor & outdoor
- Mass participation in small spaces 20+ children in the space of one court
- Build fundamental physical skills
- Suitable for children with physical disabilities or learning difficulties

These lessons are designed to focus on fundamental skills and is aligned with the NZ curriculum. The programme itself has a range of different options available, and programmes can also be developed to cater for a school's specific needs.

Primary Schools:

Badminton North Harbour ran Shuttle Time Programmes at a number of primary schools. We were able to deliver a five-week programme to Glamorgan School with more than 500 children having the chance to experience our sport. This year Orewa Primary School came on board and we designed a three-week programme specifically for them. Other Primary schools involved with Badminton North Harbour were Kristin School, Campbells Bay, Pinehurst School to name a few. During the year we were pleased to see these kids attending our Clubs, Holiday Programmes and After School Programmes.

Intermediate Schools:

BNH has worked with number of Intermediate Schools throughout the year delivering taster and skills sessions. We helped some of the schools organise their teams that competed in North Harbour's Intermediate School League. Following these visits many students took up the opportunities to be involved in further Badminton North Harbour programmes. All intermediate schools we have delivered sessions to have shown great potential. We will look forward to working with them again next year.

Secondary Schools:

This year we have had great success delivering sessions to a number of Secondary Schools. Badminton North Harbour has worked with over 500 secondary school students this year. We were involved in coaching NCEA Achievement Standards and assessing the students. We also delivered skills sessions to the school representative teams who took part in the Inter-School competitions organised by Badminton North Harbour and College Sport.

Due to the successful delivery of our badminton programme to schools, we have experienced significant interest in our other programmes such as School Holiday programme, After-school programmes and in our junior clubs.

After School Programmes:

After School programmes continue to be hugely popular group for school aged children. We have had great success delivering

these programmes. They are being run at another venue, Glenfield College and together with our original locations at Harcourts Cooper & Co North Harbour Badminton Centre, Active Badminton Centre and Orewa Badminton Centre we are growing each year. Also, we will be providing these opportunities to Hobsonville Point School during Term 4.

School Holiday Programme:

The Badminton North Harbour Holiday programme provides a great environment for children to learn and progress in the world of badminton. It's a great way for children to have fun, learn new skills and meet new friends. This four half-day event is run as an incentive awards programme which allows players to get a gauge on their ability as they work towards badges. The skills required increase in difficulty as they move higher in their skill level to earn higher badges. This year we have seen consistently high numbers, having more than 35 children in each session. We were also able to help the AUT Millennium holiday programmes by running two hours sessions, which involved teaching their children basic skills and rules of badminton.



Beginner Badminton:

Our Beginner Badminton course is always in a great demand. In this programme, basic techniques of badminton are being taught to children and adults. This course is suitable for beginners and to those who are looking to polish their skills. We ran one early this year with more than 15 students attending each group. We are going to run this again in October/November and have already reached capacity in the children's group. We are looking forward to seeing these new students.

Badminton North Harbour is always thankful to have many coaches, sponsors and supporters involved in our organisation. Without them many programmes and events would not be possible.

This was the first International North Harbour has hosted in a number of years. Being scheduled so early in the year, the number of entries was very positive with 131 players registered. This BWF Future Series Event had a prize pool of \$USD5,000.00 and an entry fee of \$NZD100.00. Players from 10 countries were represented at this four-day event. Trophies were supplied by Barclay Engravers and were of a very high quality. On finals day, North Harbour, in conjunction with Oceania Badminton, organised the Spit Roast Company to provide hot roast rolls and salad to all players, followed by ice creams before everyone headed away. Our thanks go to our volunteers who make the event such a successful one.

North Island/North Harbour Open 2018

This tournament from 20-22 April was attended by 70 players. Perpetual trophies representing the North Island part of the event were awarded alongside North Harbour's trophies plus individual trophies were presented to the winners and runners up. Thank you to Badminton North Harbour staff and our very own volunteers for their time and experience in producing a successful event.

North Harbour u19 Open

The North Harbour u19 Open was held from 11-12 August and hosted 53 players from around the Northern Region and beyond. The standard of badminton was very high during this event with finals being the exciting contest that it promised to be. North Harbour players were very dominant with Oscar Guo winning the men's singles, doubles and mixed doubles with fellow North Harbour player, Tamara Otene. Shaunna Li won the women's singles.

North Harbour u15 Open

The North Island/North Harbour u15 Open was held from 7-8 June. The draw of 84 players was played over two days with winners and runners up receiving medals and prize money. Plate winners also received medals. North Harbour's Chris Benzie won the boys doubles and mixed doubles with partner Natasha Alijabar, who also won the girls doubles.

New Zealand Community Trust Secondary School League 2018

150 Secondary School teams from 15 schools took to the courts this year in a range of grades from A to C (social). The increase of 6 teams from 2017 continues the trend of school age children wanting to play badminton. The social section in both senior and junior age groups is always the most popular with the greatest number of entries.

The senior competition with 87 teams was held in the second term. The Girls A grade entry was combined with the B grade due to lower numbers entering the A grade event this year. The Girls C grade was again very popular with over 19 teams entered. The boys' teams were run in separate A & B grades as the numbers in A grade continues to increase. B Grade was our biggest event for the boys with 24 teams registered. The boys C grade took place this year with five teams, after a 2017 absence. Teams who played in a combined grade were still awarded places for their respective grades in which they had entered.

The junior section, held in the third term, is smaller in team numbers than the seniors, however a good jump from 46 to 63 teams is projecting well for the future. The Junior Girls A & B combined to make one large event while again, the C grade teams were plentiful in the girl's division to remain as being the most popular of the grades. Because of the entry numbers in both senior and junior B grade events, we were able to run two separate competitions; one at Badminton North Harbour and the other at Active Badminton.

Prize giving was held on the last Wednesday (girls) and Thursday (boys) of the school term where College Sport medals were awarded to the winners and runner up teams of each grade. This was followed by pizzas for all participants. Thank you to all teachers, parents, sport managers, sport coordinators and supporters who gave their time to make the Secondary School League a success.





FOR THE YEAR ENDED 30 SEPTEMBER 2018

REPORTING ENTITY

Badminton North Harbour (Inc.) is an Incorporated Society incorporated under the Incorporated Societies Act 1908.

The financial statements of Badminton North Harbour (Inc.) are a special purpose statements based on the following accounting policies adopted by the Board and prepared for and used to report to members on the financial transactions and financial position of the society.

MEASUREMENT BASE

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historical cost basis are followed by the entity.

SPECIFIC ACCOUNTING POLICIES

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied.

GOODS AND SERVICES TAX

The financial statements have been prepared on a GST exclusive basis (except for trade payables and receivables) and any tax owing at balance date is shown in the Statement of Financial Position. GST is accounted for on an invoice basis.

CASH

The amount shown for cash and bank is the total of amounts held on current, call or savings account or in notes and coins for use in the day-to-day management of the society.

DEBTORS AND CREDITORS

Debtors and creditors are recorded at estimated realisable value. Subsequent measurement is at amortised cost, meaning the present value of the expected future cash inflows or outflows.

STOCK

The amount shown for stock is a total value of all goods held by the society for use or resale. These are recorded at the lower of cost, based upon the first in first out method, and net realisable value.

FIXED ASSETS AND DEPRECIATION

Fixed Assets are stated at cost less accumulated depreciation. Depreciation has been based on the estimated useful life of the asset as assessed by the society. Fixed Assets are being depreciated at the following rates:

INCOME RECOGNITION

The society is funded principally by fees received from court usage. Other income is received from sponsorships, donations and grants, Council contributions and sales of food, alcohol and badminton equipment.

All receipts are treated as income when received except where income is received in advance in which case it will be brought to account in the period to which it relates. Income contingent upon conditions to be met is only treated as income once the conditions have been satisfied.

A system exists for allocating the costs of hiring courts for a specific purpose to the individual cost centres to which they relate. This effectively results in internally generated income and expenditure of matching amounts being shown in the financial statements. In the current year this had the impact of grossing up revenue and expenditure by \$98,530 (2017-\$92,383)

TAXATION

No income tax has been provided as the society has been granted an exemption from income tax due to its amateur sporting body status, under section CW46 of the Income Tax Act 2007.

INCOME IN ADVANCE

Card holder funds represent a liability to the society as they are funds that patrons have added to their cards but not yet used. Amounts added to cards are recorded as income when the credits are used by booking court time.

BARTERCARD

Bartercard credits shown in the Statement of Financial Position are recorded when transactions are recognised by Bartercard New Zealand Ltd as having been properly recorded and authorised. Bartercard liability disclosed on the Statement of Financial Position represents the net liability (after the sponsorship received) to Bartercard. The sponsorship received from Bartercard is recognised in the Statement of Financial Performance in the period it is related to.

CHANGES IN ACCOUNTING POLICIES

There have been no changes in accounting policy during the year.


