That is a constant work on for Glenn's team and the Board and we can assure you that we are constantly exploring opportunities to acquire new or additional facilities and opportunities to enable us to cater for the ever increasing numbers of people who wish to participate in our amazing sport.

Congratulations on a fantastic season in 2019. Long we may continue to reign.

CHIEF EXECUTIVE'S REPORT

It's been another busy year for us all at Harbour Badminton. The two facilities we use continue to show an increase in bookings as well as organised programs and activities at satellite venues throughout the Harbour Region. Badminton North Harbour and Active Badminton continue to provide exceptional facilities for our badminton community to enjoy and they remain extremely busy year-round.

Badminton North Harbour would like to acknowledge our naming right partner Harcourts Cooper & Co whose support is truly exceptional. Harcourts Cooper & Co are a proactive community based real estate company who have tremendous presence within our Harbour region. They are at the forefront of sport in our area and contribute a vast amount to community sporting organisations. A huge thank you to Martin Cooper, Louisa Loughran and the Harcourts Cooper & Co team for all they do for us.

We have again seen a fantastic year results wise, with Harbour players and teams excelling internationally, nationally and domestically. Oscar Guo won the Men's Singles at the Oceania Championships in Melbourne and was part of the New Zealand team that included Abhinav Manota, Maika Phillips, Edward Lau, Dylan Soedjasa, Anona Pak, Alyssa Tagle and Justine Villegas. Several members of this team went on to represent New Zealand at the Sudirman Cup in Nanning, China. Edward Lau won the Oceania Junior Men's Singles and Shaunna Li won the Women's Singles at the same event. Josh Feng and Catelyn Rozario were also selected in the New Zealand junior team for the Oceania Championships. At the National Championships, Harbour players featured in all five titles this year, which is a truly remarkable feat.

In team's events, Harbour has had one of its most successful seasons. Our Wisden Cup team again featured on Sky TV and won the Yonex New Zealand Division 1 Team Championships. Our two teams in Division 2 (Slazenger Cup) finished 1st and 3rd which is simply outstanding. The team in Division 3 finished 2nd and our two teams in Division 5 finished 1st and 2nd respectively. In the Junior events our U19 team finished 1st, and our U17, U15 and U13's finished 2nd at the NZ Junior Team Championships. Our numbers in representative teams continues to grow, as do the development squads and school programs.

We have hosted a number of events this year including the Yonex North Harbour International back in March. A big thank you to Badminton Oceania and Badminton New Zealand for their support with this. Our tournaments this year have included a senior open, U13 and U17 open, as well as representative fixtures, domestic events and school leagues.

Badminton is really healthy on the North Shore and I would like to acknowledge firstly the Badminton North Harbour staff. Annabelle and all her tireless work in our office, Fanny and her team of amazing coaches, Lisa and her events team, Karen making sure everything adds up and our financials are in order, Justine with her team in the shop and bar, Mani ensuring all our children have the opportunity to play our sport and Neville keeping on top of the repairs and maintenance of our facility. They all contribute so much in their areas of expertise; we simply could not function as well as we do without these passionate Harbour Badminton people. To our

We continue to look at ways to provide pathways and opportunities to all players and the community as a whole. COACHING MANAGER'S REPORT

This year North Harbour has had many good results from our junior, senior, and masters players. It is a great feeling to see everyone harvest what they had been working toward in training throughout the year.

Our Junior players managed to get good results consistently in 2019. Shaunna Li showed that she is the one of the best New Zealand female athletes, winning many tournaments she participated in. She took the titles of women's singles, national champion, was a member of the North Harbour 2 team that won the Slazenger Cup, picked up titles at the U17 and U19 opens and Yonex New Zealand National Championships. Due to personal reasons, she did not participate in World Junior in Kazan, Russia. Edward Lau has proved to be the top U19 player in every event. He attended the BWF World Junior Championships this year and managed to get to the third round before losing to the eventual men's singles champion, Kunlavut from Thailand.

For our U13 and U15 age groups, we are very proud of players like Lechuan Xiao and Lilian Cao who performed very well in age group opens and the Yonex New Zealand U13 National Championships. Lilian managed an upset win against her nemesis, Nanna Siegemund from Auckland in girls' singles with a three-game match. Lechuan came a creditable runner up at the same event in boys' singles and boys' doubles.

In other team events, we also had favourable results. We won three runner-up, and one winner's title at the Yonex New Zealand Junior Team Championships in Palmerston North. At the inter-association level this year we managed to win both Wisden and Slazenger Cups. It was a tough final in both tournaments and our players, with their best effort, were able to overcome every opponent from the other associations in their draw. In Masters and Veterans, we also won the New Zealand title against Auckland teams in the final.

North Harbour player, Abhinav Manota is trying to qualify for the Tokyo Olympic Games 2020 in both singles and doubles, with

Oliver Leydon-Davis from Waikato. He has been travelling since early 2019 to earn points toward this goal. He came runner-up in both singles and doubles at the Bulgarian Open. Abhinav will be training for six weeks in Denmark during November/December and competing in some tournaments while he is in Europe. We wish him all the best for his campaign.

Edward Lau, Joshua Feng, and Catelyn Rozario were selected by Badminton New Zealand to represent their country at the BWF World Junior Championships in Kazan, Russia. It was a good experience for them to compete with other top junior players from around the world.

Last, but not least, Edward Lau, Shaunna Li, Anna Ryu, Richard Lin and Farah Thien will be traveling to participate at the Singapore Youth International tournament from 18-24 November. They will continue their trip by travelling to Indonesia where they will attend an intensive 3-5 week training camp at the Djarum Club. It is good experience for them to have twice a day, six days a week training session in preparation for next year's tournaments.

Words are not enough to express my sincere thanks and appreciation to the coaches, parents, and staff who are involved in our process in order to achieve results and most importantly to build complete character in our players.

DEVELOPMENT OFFICER'S REPORT

After School Programmes:

The After School Programme continues to be a hugely popular group for school children. We have had great success delivering these programmes. Currently in Term Four we have received over 200 enrolments at three different locations which are, Harcourts Cooper & Co North Harbour Badminton Centre (2 sessions per week), Active Badminton Centre and Orewa Badminton Centre. We have delivered these sessions to over 1,000 children this year. The idea of the project is to get more children involved and trying out new sports throughout the year, where students can play after school hours and we look forward to seeing these young players again in 2020.

BWF Shuttle Time:

Badminton North Harbour has been involved in delivering the Badminton World Federation Shuttle Time programme to Primary, Intermediate and Secondary schools for over two years now. Shuttle Time lessons are designed to provide children with a positive image of badminton through many opportunities to have fun, engage with others and experience success.

It is a games-based programme that focusses on fundamental skills and is aligned with the New Zealand curriculum. The programme itself has a range of different options available, and programmes can also be developed to cater for a school's specific needs.

Beginner Badminton:

This is always a great event as we get to be involved with number of new children and adults helping them improve their badminton skills. In this course, basic techniques of badminton are being taught to the children as well as to adults. This course is suitable for beginners and to those who are looking to polish their skills. We ran one early this year with more than 15 students in each group.

Our next Beginner Badminton course is starting in February 2020. We are looking forward to seeing new students.

Holiday Programme:

The School Holiday Programme has always been a popular activity for children in the region, and a great feeder for those introduced to badminton through our school visits. It's a great way for children to have fun, learn new skills and meet new friends. It is a Badminton North Harbour incentive awards programme which allows players to get a gauge on their ability as they work towards badges that increase in difficulty as they progress with higher skills. This year we have seen consistently high numbers, having more than 32 children in each session.

Also, we were able to help AUT Millennium, Harbour Sport and Skids with their holiday programmes, which involved teaching their children basic skills and rules of badminton. It is positive to have other groups using badminton as part of their programmes.

Secondary School:

This year Badminton North Harbour worked with number of secondary schools. We managed to help with coaching and organising their senior teams that competed in the Secondary Schools League at Badminton North Harbour. We have had great success delivering sessions to over 400 students. We were involved in coaching NCEA Achievement Standards and assessing the students.

As a result of our programme delivery to the schools we have experienced significant interest in our other programmes such as



the School Holiday Programme, After School Programmes, and in our junior clubs.

Intermediate Schools:

Badminton North Harbour has worked with and run taster sessions & skills sessions in many Intermediate Schools this year. Also, we helped some of the schools to arrange their teams that competed in North Harbour's Intermediate School League. Following these visits many students took up the opportunities to be involved further Badminton North Harbour programmes. All the intermediate school pupils we have delivered sessions to had great potential and we look forward to working with these players next year.

Primary Schools:

Badminton North Harbour were able to deliver taster sessions, ranging between three to nine-week programmes to primary schools implementing the Shuttle Time programme. We were able to deliver a three-week programme to Beachhaven Primary School with more than 200 children having the chance to experience our sport. Other Primary schools involved with BNH were Kristin School, Campbells Bay, Pinehurst and many more. After our time at these schools it was great to see these juniors attending our Clubs, School Holiday Programmes and After School Programmes.

Badminton North Harbour is always so thankful to have many experienced coaches to assist in our development programmes. To all our sponsors and supporters, we thank you, as without them none of these would be possible.

Yonex North Harbour International 2019

From 21-24 March, Badminton North Harbour hosted 130 players from 12 countries. This BWF Future Series Event had a prize pool of \$USD5,000.00 and an entry fee of \$NZD100.00. Trophies were supplied by Barclay Engravers and were designed in a similar theme to the 2018 trophies, keeping consistency over the years. On finals day, North Harbour hosted guests on court-side hospitality tables. All titles went to overseas players from China, Vietnam and Australia. Our special thanks go to our staff and volunteers who make the event such a successful one with their time and commitment.

North Harbour Open 2019

This tournament, from 17-19 May, was attended by 72 players, the same number as 2018. Due to the NZ Team playing away at the Sudirman Cup, the numbers could have been greater. North Harbour's perpetual trophies, as well as individual trophies were presented to the winners and runners up. Thank you to Badminton North Harbour staff and our very own volunteers for their time and experience in producing a successful event.

North Harbour U17 Open

The North Harbour U17 Open was held from 10-11 August and hosted 89 players from around the Northern Region and beyond. This is the largest junior tournament that North Harbour has hosted. The standard of badminton was very high during this event with finals being the exciting contest that it promised to be. North Harbour's Shaunna Li was very dominant winning the girls' singles, doubles and mixed doubles events.

North Harbour U13 Open

The North Harbour U13 Open was held from 22-23 June. The entry of 69 players was the largest entry we have had for this age group, showing the increasing numbers of juniors playing badminton. Championship winners, runners up and plate winners' received North Harbour medals and prize money. North Harbour's Lechuan Xiao won the boys doubles with his Auckland partner, Darren Wee.

Yonex NZ U19 National Championships

The YONEX New Zealand U19 National Championships was hosted by Badminton North Harbour from 26-28 October. This event had players from as far south as Canterbury and Nelson, with the majority from the Northern Region. North Harbour players featured in each of the five finals and won three of them. The event was a great success with players, coaches and spectators leaving with positive memories.

New Zealand Community Trust Secondary School League 2019

120 Secondary School teams from 15 schools took to the courts this year in a range of grades from A to C (social). The steady number of teams continues the trend of school age children wanting to play badminton. The social section in both senior and iunior age groups is always the most popular with the greatest number of entries.

The senior competition with 81 teams was held in term two. Because of the increased numbers in A Grade, these were standalone events in 2019. B Grade was again steady in numbers proving to be a popular section for many schools. The Girls C grade was again in hot demand with over 23 teams entered. The boys B grade was consistent with 18 teams registered. The boys C grade took place this year with six teams, an increase from 2018. The Active Badminton Centre was utilised for B Grade boys and girls teams whose schools are in the Northern part of the North Harbour area.

The junior section, held in the third term, is smaller in team numbers than the seniors, however a good jump from 46 to 63 teams is projecting well for the future. The junior Boys A grade and B grade played as one grade because of the entry numbers, however, were awarded medals in each grade. 





BADMINTON NORTH HARBOUR INCORPORATED STATEMENT OF ACCOUNTING POLICIES

FOR THE YEAR ENDED 30 SEPTEMBER 2019

1. REPORTING ENTITY

Badminton North Harbour Incorporated ("BNH") is an Incorporated Society registered in New Zealand under the Incorporated Societies Act 1908. (Incorporation number: 459164)

The financial statements of Badminton North Harbour (Inc.) are special purpose financial statements based on the following accounting policies adopted by the Board and prepared for and used to report to members on the financial transactions and financial position of the society. The Board has determined that the use of a special purpose framework is acceptable based on the limited readership of these financial statements.

BNH's primary function is to provide its members and the general public with a quality badminton facility and diverse range of badminton services and programmes. BNH strives to increase player participation, enjoyment and high achievement through sound business practice and a commitment to developing badminton.

BNH has 21 affiliated clubs with a total of 853 registered players.

2. MEASUREMENT BASE

The financial statements are prepared on the historical cost basis.

3. PRESENTATION CURRENCY

These financial statements are presented in New Zealand dollars (\$), rounded to the nearest dollar.

4. SIGNIFICANT ACCOUNTING POLICIES

The following significant accounting policies set out below have been applied consistently to all periods presented in these financial statements.

A) GOODS AND SERVICES TAX

With the exception of trade payables and receivables, all items are stated exclusive of GST. Any GST owing at balance date is shown in the Statement of Financial Position. GST is accounted for on an invoice basis.

B) CASH

The amount shown for cash and bank is the total of amounts held on current, call or savings accounts, including petty cash and cash floats used in the day-to-day operations of BNH.

C) DEBTORS AND CREDITORS

Debtors are recorded at estimated realisable value, making allowance for any amount the Board and management consider are unlikely to be collected. Creditors are recorded at the amount BNH expects to pay to settle the debt. Where liabilities are known to exist at balance date but no invoice has been received, costs are accrued based on amount expected to be spent post balance date.

D) STOCK

The amount shown for stock is a total value of all goods held by the society for use or resale, including badminton equipment, and food and beverages. These are recorded at the lower of cost, based upon the first-in first-out method, and net realisable value.

E) FIXED ASSETS

All Fixed Assets are measured at cost less accumulated depreciation. Any gain or loss on disposal of fixed assets (calculated as the difference between the net proceeds from disposal and the carrying amount of the item) is recognised in surplus or deficit. Assets created by BNH are capitalised at cost, including expenditure over the minimum threshold of \$500.

F) DEPRECIATION

Depreciation is charged based on the estimated useful life of an asset. The Board deem that these rates are a suitable proxy for estimating the depreciation and therefore the useful lives of the assets. The depreciation rates used are:

G) INCOME RECOGNITION

The society is funded principally by fees received from court usage. Other income is received from sponsorships, donations and grants, Council contributions and sales of food, alcohol and badminton equipment.

i) Court Hire

Cardholders add funds to their card for court usage. Income is recognised when the court is utilised, or when a court booking has been cancelled after the minimum notice period expires.

ii) Player Revenue

This includes registration, representative, coaching, and training fees. Income is recognised in the period to which the fee relates, and any fees received before year end relating to the next financial year will be recorded in income in advance.

iii) Sales

This includes sales of badminton equipment through the Pro Shop, and sales of food and beverage through the bar. Income is recognised upon receipt as the transfer of ownership occurs at the point of sale.

iv) Grants, Donations, and Sponsorship

Income is recognised upon receipt for donations and sponsorship. Grant income which contain a use or return condition is contingent upon conditions being met. These grants are only treated as income once the conditions have been satisfied, and recognised in the corresponding period. Until these conditions are met, the funds are recorded as a liability.

G) INCOME RECOGNITION (contd)

v) Internally Generated Revenue

A system exists for allocating the costs of hiring courts for a specific purpose to the individual cost centres to which they relate. This effectively results in internally generated income and expenditure of matching amounts being shown in the financial statements. In the current year this had the impact of grossing up revenue and expenditure by \$96,266 (2018: \$98,530)

H) TAXATION

No income tax has been provided as the society has been granted an exemption from income tax due to its amateur sporting body status, under section CW46 of the Income Tax Act 2007.

I) INCOME IN ADVANCE

Card holder funds represent a liability to the society as they are funds that patrons have added to their cards but not yet used. Amounts added to cards are recorded as income when the credits are used by booking court time.

J) BARTERCARD

Bartercard credits shown in the Statement of Financial Position are recorded when transactions are recognised by Bartercard New Zealand Ltd as having been properly recorded and authorised. Bartercard liability disclosed on the Statement of Financial Position represents the net liability (after the sponsorship received) to Bartercard. The sponsorship received from Bartercard is recognised in the Statement of Financial Performance in the period it is related to.

5. CHANGES IN ACCOUNTING POLICY

There have been no changes in accounting policy during the year.

6. GOING CONCERN

These financial statements have been prepared under the assumption that BNH will continue to operate in the foreseeable future based on the expected ongoing support from grant funders and continued high level of usage from the community and local clubs.
