Update Planning / Procedures for moving out of lockdown — Overview from Glenn

All staff are working at home and once a week they have a full staff Zoom meeting.

Prior to Level 3 restrictions been removed

Sanitisers will be placed behind each court.

When we reach Level 2

Refer to the Sport NZ schedule – Sport and Recreation Activities at Alert Levels 1-4 Domestic events to be offered to all players - starting with Ladders.

The Pro shop hours will be extended to assist with court bookings, to authorise the court lights when the forms are completed naming all players / spectators by card holders and collect forms.

Templates to be setup for Clubs to use so all players and spectators can be listed each day - full name, mobile phone numbers and email addresses

Instructions to be emailed to all Harbour card holders to outline the information that will be required when booking courts after the Centre reopens at Level 2.

Coaches to complete the same template re their squads – players and spectators

Overview of discussions with David Reeks:

Refer David's email for his suggestions for tracking players etc as we move to Level 2. Cards for every player – cost 4.50 + GST

Results to date from the Questionnaire:

Glenn discussed the latest results from the online questionnaire relating to the Covid-19 participation post alert level 4. There have been 209 responses to date.

Many rep players would like to complete the season but not to travel out of the Auckland area.

26% would travel out of the Auckland area.

Level 2 - 75% of players want to play

Level 1 – 88% of players want to play

The results also show that players would like Wisden and Slaz. to be played later in the year.
