# **CHIEF EXECUTIVE'S REPORT**

Well, we certainly live in what could best be described as strange and unusual times. Covid 19 continues to change the landscape for sport, not only in our community, but throughout the world. This year we have endured not one but two lockdowns, throwing our season and our sport into a sense of uncertainty and confusion. Through events, competitions, tournaments and general court hire, everybody has had to accommodate changes. The flexibility of our badminton community has been tested but has risen above the challenge and continues to develop and prosper.

We continue to strive to provide our community with quality badminton facilities, and therefore, a quality badminton experience. Our two great venues at Bond Crescent and Apollo Drive are being utilised to very nearly maximum capacity as we continue to manage such high demand from our community to participate in our sport. From Harbour representatives, clubs, schools, and juniors we are seeing an ever-increasing demand for players to experience badminton. We continue to offer opportunities to our playing community, ensuring there are pathways for all, no matter what your level is to participate in our sport.

Badminton North Harbour would once again like to acknowledge our naming right partner, Harcourts Cooper and Co, whose support is truly exceptional. Harcourts Cooper & Co are a proactive community based real estate company who have tremendous presence within our Harbour region. They are at the forefront of sport in our area and contribute a vast amount to community sporting organisations. The year began with an element of uncertainty. Once again international competition was not something that was going to be possible. In the domestic competitions North Harbour again continued to perform well with many of its senior players winning national titles and defending their national teams' titles, winning both the prestigious Wisden and Slazenger Cups which were played in August. We saw more success with our Division 4 team winning the Northern Regional title and our master's Division 1 and master's 4 teams their respective competitions.

What was truly pleasing was seeing the continued success of our junior players who in 2021 were simply outstanding. At the New Zealand Junior Teams Championships our U13 teams finished 1st and 2nd, our U15 team finished 1st, our U17 finished 1st and under 19 finished 2nd. This illustrates we have a very successful development program that is exceptionally well supported by players and their parents. This provides a fantastic environment for our players to learn and develop in.

I have been involved in Harbour badminton for over 40 years now and the single most important thing that I can say about our association is that we are like one big family. We all care for each other and work hard to ensure the environment we share is simply the very best we can provide at all levels.

Our domestic events which include Summer League, Ladder competitions and tournaments continue to show very strong growth with record numbers enrolling. Managing these increases, at times, can certainly be challenging, and we appreciate our players patience and flexibility as we try and ensure everyone can participate.

To our clubs that again have shown us such incredible support we thank you for providing so many opportunities for our community, providing excellent environments and opportunities for everyone to enjoy the sport of badminton once again.

We have managed to upgrade some areas of our facility this year which includes our northern changing rooms and board room area. This is part of our continued facility maintenance schedule ensuring we keep our facility modern, up to date and fit for purpose. The latest Covid lockdown has caused significant disruption and stress to families and businesses around the Auckland area, Badminton North Harbour has not been immune. The Board and Glenn are conscious of the fact that by working closely together - staff, clubs, players, and other interested parties we will not only be able to maintain sufficient funding to meet our commitments but also to keep the Association going forward in both the short and long-term.

It is extremely important to the Board that we continue to ensure that all players whatever their level have the opportunity to play the sport we love.

The Board continues to look at all options for a new building to cater for the increased numbers wanting to play Badminton.

As in previous years, it is well documented that we are struggling with the lack of courts at peak times. As part of Badminton North Harbour's strategic plan, the Board is making good progress to expand our facility options to ensure we can cater to the growing numbers. Auckland Council, Aktive and local Boards are committed to assisting us to secure an opportunity that will help us build and expand our presence in the North Harbour region. Badminton North Harbour continues to be in talks with interested parties; and is now somewhat closer to providing something concrete to our members in the new year.

Competitions both at a representative level and internally were once again severely affected due to the August lockdown. This made it extremely difficult to finish existing competitions let alone start up new ones. Having said that we still managed, where we could, to maintain high standards and collect our usual percentage of titles along the way. Much of our success can again be put down to the coaching team headed by Fanny Megahwati who maintained and adapted the players' training schedules during the various lockdown periods. In particular, her online fitness coaching programme proved to be very popular with an average of 25 players in attendance at each session.

One good thing that did come out of the Covid mess this year was the continuation of the Learn Coach New Zealand Badminton League. Played between 4 franchise teams over 2 nights per week during winter this competition continues to grow due to the great support from the Badminton community. The competition is shown live on Sky TV and was once again dominated by players from North Harbour who made up half the playing numbers. It is fair the say that with more sponsorship and promotion there is an opportunity for this competition to have a greater impact in the years to come.

On behalf of the Board, I would like to acknowledge our naming right partner Harcourts, Cooper & Co, also all Trusts, companies, and groups that have supported our Association this year.

The Board would like to acknowledge a huge thank you to Glenn Cox our Chief Executive and the dedicated staff of Badminton North Harbour who have ensured the continued running of our Association under very difficult circumstances.

Finally, a huge thank you to my fellow Board members, for your ongoing support, knowledge, vision, and expertise in such a challenging year have ensured our Association is in a good position to move forward into 2022. It is a privilege to be a part of such a proactive Board.

I look forward to seeing everyone on the court in 2022 - fresh and invigorated.

# **DEVELOPMENT OFFICER'S REPORT**

#### **BWF Shuttle Time:**

For the past four years, Badminton North Harbour has been delivering the Badminton World Federation's Shuttle Time program to primary, intermediate, and secondary schools. Shuttle Time lessons are designed to involve children in a positive experience of badminton by giving them several opportunities to have fun, interact with others, and succeed.

It has been adopted nationwide in New Zealand and is a great resource not only for us to use, but also for anyone who wants to get credible badminton plans and lessons through YouTube. It's a game-based program that emphasizes fundamental skills, while following the education curriculum. The program itself comes with a variety of options and can also be customised to meet the requirements of a specific school.

#### **Beginner Badminton:**

The demand for our Beginner Badminton course is consistently high. Basic badminton techniques are taught to both children and adults in this course. This program is suitable for both beginners and those wishing to improve their skills. We were lucky to have been able to offer this course in term one before the Covid-19 lockdown and managed to repeat this course for children in Term two. Our next Beginner Badminton course was scheduled for the beginning of November, however, we had to cancel this due to the uncertainty around Covid-19 alert levels.

#### **Holiday Program:**

This year, we've had consistently high participation, with each session reaching capacity. The Badminton North Harbour Holiday Program provides a great environment for children to learn about badminton and is a great feeder for those who have been introduced to badminton through our school visits. It's a fantastic opportunity for young players to have a good time while learning new skills and making new friends. This Badminton North Harbour incentive awards program allows players to get a sense of their abilities, as they strive towards badges that get more difficult as they gain more skills.

We were also able to assist with the Tania Dalton Foundation holiday programs this year, which included teaching the girls fundamental badminton skills and rules. It's encouraging to see other organisations, including badminton, in their programs.

#### **After School Programs:**

The After School Program continues to be popular and successful for students. However, we were unable to continue delivering these sessions in terms three and four due to the Covid-19 lockdown.

After School programs are offered at three different locations: Harcourts Cooper & Co North Harbour Badminton Centre (2 sessions per week), Active Badminton Centre, and Orewa Badminton Centre. All three locations are showing increased participation. In term two, we were also able to be involved with Albany Senior High School, where we delivered three sessions to over 1000 students across an eight-week period. The goal of the project was to get more children participating and trying new sports throughout the year, with students able to participate beyond school hours. We hope to see these young players again in 2022.

#### **Secondary School:**

Badminton North Harbour collaborated with several secondary schools in 2021. We were able to assist with coaching and organising their teams, who competed in the Secondary Schools League at Badminton North Harbour. This included Rangitoto College, Albany Senior High School and Pinehurst School. We've had great success delivering lessons to over 400 students across this program. We also assisted in the coaching and assessing of students who were involved in NCEA Achievement Standards.

We have seen a lot of interest in our other programs, such as the School Holiday program, after-school program, and junior clubs, because of our delivery within schools.

#### **Intermediate School:**

This year, Badminton North Harbour has worked with, and run taster sessions and skills sessions within intermediate schools. We also assisted some schools in forming their teams for the North Harbour Intermediate School League, however, this was cut short due to the COVID 19 restrictions.

Following these sessions, several students took the opportunity to participate in additional Badminton North Harbour programs. All intermediate schools to which we have run sessions, had students with a lot of potential. We're excited to work with their players again next year.

#### **Primary School:**

As with the intermediate schools, Badminton North Harbour was able to a provide primary schools with taster sessions, utilising the Shuttle Time program. We were able to deliver a three-week program to Sunnynook Primary School, allowing over 300 students to participate in our sport. Kristin School, Kingsway Primary and Pinehurst school were involved with Badminton North Harbour is some capacity. It was wonderful to see these juniors enjoying our clubs, Holiday Programs, and After School programs following our time at these schools.

Badminton North Harbour is always thankful to have many experienced coaches to assist in our development programs. To our sponsors and supporters, we thank you, as without them none of this would be possible.

sistent and good achievements in both individual and team events. During the past, we were always short of female players, however this year our girls were much stronger, and they dominated in almost every age group tournament.

At the New Zealand u13 Championships, we secured three out of five titles; u17 were dominant and won all five titles that were on offer. Unfortunately, due to the Covid alert levels at the time, we could not play the u15 and u19 national tournaments.

We did in 2021, send nine teams to the New Zealand Junior Team Championships in Palmerston North. North Harbour won the u13, u15, u17 and narrowly lost the u19 final to Auckland. With the results overall, we were very happy as we managed to have a good regeneration in our junior players.

At a senior level, we did very well. Our senior players were consistent to claim results which made the North Harbour family proud. We took all five titles at the New Zealand National Championships and defended the Wisden and Slazenger Cup titles that were also won in 2020. In the Masters' division, the number 1 team also defended their title against Auckland.

During the lockdown in the latter part of 2021, we have main-

#### **Statement of Accounting Policies**

For the year ended 30 September 2021

#### **Basis of Preparation**

Badminton North Harbour Incorporated has elected to apply PBE SFR-A (NFP) Tier 3 Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future. Previously the financial information has been presented using special purpose format. Comparative information provided has been prepared under the PBE SFR-A standard. There are no changes in the reported numbers however some amounts have been reclassified from previous years reported results.

#### Goods and Services Tax (GST)

All amounts are recorded exclusive of GST, except for Debtors and Creditors which are stated inclusive of GST.

#### Income Tax

Badminton North Harbour Incorporated is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

#### **Bank Accounts and Cash**

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

#### Stock

The amount shown for stock is a value of all goods held by Badminton North Harbour for use or resale, including equipment, food and beverages. These are recorded at the lower of cost, based upon first-in first-out method, and net realisable value.

#### Fixed Assets and Depreciation

All Fixed Assets are measured at cost less accumulated depreciation. Assets created by Badminton North Harbour are capitalised at cost, over the minimum threshold of \$1,000. Depreciation is changed based on the estimated useful life of the asset. The depreciation rates used are as the Board deem the rates are suitable. The depreciation Rates used are:

#### **Revenue Recognition**

Revenue is recognised to the extent that the economic benefits or service potential will flow to Badminton North Harbour and the revenue can be reliably measured regardless of when the payment is being made. Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duty.

Where funds are received in advance of a service being offered, or where a grant has been received but the conditions of the grant are not fully complied with a balance date, such funds are being held as a liability and only recognised as revenue when the service has been provided or conditions satisfied.
