

# Minutes of the Board meeting

Held via Zoom on 28 July 2025

The Board meeting was called to order by Karen Blank at 7:01 pm.

#### **Approval of Minutes:**

The minutes of the meeting held on 24 June 2025 were accepted and approved as true and accurate records by the Board.

### **Matters Arising:**

The fundraising café organised by junior parents had three very successful events from the bar and kitchen. North Harbour reimburses any product costs incurred. They bring their own coffee machine, and they supply better food to the public.

The sponsorship account now has close to \$20,000, including interest. The upcoming events will be the Facebook Open in August and the NH International in October. Proceeds from the Gala Dinner will be added to that account. Glenn hopes we can build it to have some more substantial funds so we can establish reasonable criteria for how we can help - Glenn spoke to them regarding fund distribution. They are happy to subsidise the travel expenses for coaches going to tournaments on weekends.

# **Correspondence In/Out:**

**Louise Wright's letter** – she is no longer playing reps and returned the captain's bag to North Harbour.

**Email from clubs requesting more courts** – declining their requests and reserving the courts for public and account holders' use. We cannot afford to offer the courts for \$12 an hour due to expenses we must address and other costs we cannot absorb. We are considering charging clubs court usage to peak and off-peak hours in the future. Glenn hopes that if we pick up Active BC and then eventually Albany Sports Hub, we will be in a position where we do not rely on funders.

There was a query from the Board about whether we can structure Active BC as a separate new entity, not part of the affiliation fees that we pay – not sure how it would fall under tax exemption or if we should create a charity.

There was a discussion on the Albany Sport Hub structure. Glenn said it will have its governance model, and we will have our own representation, which will be discussed in Thursday's meeting, 7<sup>th</sup> August, 5.00 pm. Glenn is pushing that we have our own income stream and pay back in opex. His idea for governance is one from each sport and TCT, and the chair from Upper Harbour Board, totalling five members. Karen and Chris will be involved in the discussion, as well as two

#### Windcave

We just found out that the 1.6% BNH charges on transactions don't cover the bank charges.

The board suggested increasing the transaction fee to 2% or include the account-to-account transactions to 1.6%.

### Clubs

Glenn is planning to hold a club meeting in late August on a Friday night around 6 PM to see what they want to discuss or any issues they may have.

We have addressed the lights issue and adjusted them to 85%, but they said it was too dark. Now it sits at 88% - there have been no complaints so far.

### **Corinthian Drive**

Mark has asked Denis for the list of information that North Harbour wanted and has expressed our interest in proceeding. He mentioned to Denis that we are retaining counsel and an accountant, and the list doesn't include any additional information they may require.

He hasn't received anything yet from Denis, but as soon as he does, he will distribute it to the Board.

Karen has approached Jenny Matthews and sent all the information to the person she nominated. She mentioned it was good timing and would be able to do what we needed in a reasonable time frame.

Additionally, she contacted BCCA and sent all information to date, along with a copy of the email Mark sent to Denis.

There was a discussion on whether to set up a separate entity or a charitable society.

Glenn asked Simon and Edwin to revisit our affiliation model. He plans to revert to the \$60 annual fee regardless.
